#### Responsibilities and Duties

- Prepare SLSMNC Interbranch Team for competition by delivering a structured coaching program commensurate with physical, technical, tactical, and mental requirements of competition.
- Coordinate and/or conduct monthly training sessions - July to November.
- Coordinate Assistant Coaches who specialise in beach, swim, board, and ski disciplines for training sessions.
- Ensure attendance records are kept for all training sessions.
- Ensure medical and contact information for participants are available at all training sessions.
- Attend predetermined selection carnivals and other selection trials.
- Coordinate Interbranch Team activities in cooperation with the Team Manager and authorised by the Director of Surf Sports.
- Facilitate selection of the SLSMNC Interbranch Team.
- Understand and ensure adherence to relevant SLSA, SLSNSW and MNC policies  
Particularly:
  - SLSA Competition Eligibility Policy 5.04
  - SLSA Member Protection Policy 6.05.
  - SLSA Visits and Tours Policy 6.26
  - SLSA Grievance Procedure Policy 6.06
  - MNC Team Member Agreement & Code of Conduct.
  - MNC Interbranch Development Squad and Team Selection Policy.
- Liaise with the Director of Surf Sports on any competitor Drafting requirements for the Interbranch Team.
- Attend Branch meetings to keep the Branch Council informed of the progress of team training and selection.
- Provide a written report to the Branch Director of Administration by the 31<sup>st</sup> December detailing the MNC Interbranch team's overall performance, individual performances, and recommendations for future consideration.

Desirable Attributes:

- Hold a current SLS Coaching accreditation (Minimum Foundation/Development).
- Be a current financial member of an MNC SLS Club (compulsory).
- Working with Children Check (compulsory).
- A good knowledge of competition rules particularly in relation to the NSW Interbranch Championship events.
- Demonstrated rapport with SLSMNC athletes.
- Ability to be analytical and unbiased in identification of athlete talent.
- Demonstrated leadership and ability to work in a team environment.
- Good organisational skills.

The MNC Board of Directors will be responsible for the appointment of the Team Coach position.
