MNC DEVELOPMENT SQUAD

The Development Squad provides an opportunity for competitors across the Branch to come together from July - November to train together with experienced qualified coaches. The objective is to improve skills and fitness of squad members as well as help develop relationships across the Clubs. This will provide a great competitive surf sports environment within our Branch as well as develop a strong and competitive MNC Interbranch Team. Skill development and good fitness will also assist in us developing strong and skillful surf life savers.

The development squad will consist of members nominated by their clubs in the U/12 to Open categories both male and female. As a member of this squad you will be eligible for final selection in the MNC Inter Branch team.

Nomination Criteria for MNC Development Squad

- (1) Training days will be conducted and there is an expectation that you attend these training sessions, any absences must be approved by the MNC Interbranch Team Coach.
- (2) Individual training profiles should be maintained by the member and submitted with nomination.
- (3) As this is a high level of competition nominees should have above average level of fitness and competence in their respective disciplines.
- (4) Nominees must be proficient.
- (5) Nominees must be current financial members of an SLS MNC Club.
- (6) Nomination form must be submitted prior to participating in the Development Squad.
- (7) Nomination form must have Club endorsement.
- (8) Medical and Emergency Contact information form must be completed and submitted with the nomination.
- (9) Only completed and signed nomination forms will be accepted.
- (10) If under 18yrs of age, nominees must have signed parent/guardian consent to nominate.

MNC Inter Branch Team Selection Policy

The selected MNC inter branch team will consist of:

- U/12, U/13, U/14, U/15 age groups consisting of 3 male (two water and one beach competitor) and 3 female members (two water and one beach competitor) in each age group.
- 1 Youth team consisting of 4 male & 4 female U/17 members only (three water and one beach)
- 1 Open team consisting of 4 male & 4 female U/19 or Open members only (three water and one beach competitor).

The process for final selection of the Interbranch team will be inclusive of the following

1. Consideration and review members results from previous SMNC Branch Carnivals and Interbranch Selection Trials, NSW Country Championships, NSW Inter-Branch Championship, NSW State Championships, Australian Open and Youth Titles.
2. Consideration and review results from any carnivals conducted outside the MNC Branch
3. Consideration and review MNC Development Squad members training performances, attitude and commitment.

Selection Panel Members

The chairperson may call on other MNC members to act as a further selector.

An Interbranch Selection Panel meeting will be convened. One representative from each MNC Cub will be invited to attend this meeting.

Selected Team Members Conditions

- Once the team is selected all functions come under the control of the Director of Surf Sports in consultation with the Team Coach and Team Manager.
- Any issues or disputes from a team member/s are to be directed to the SLS MNC Director of Surf Sports only.
- The Team Coach and Assistant Coaches are the selectors of the team members individual disciplines and team events to be conducted at and on the day of the championship.
- Training sessions are at the discretion of the Team Coach and any absences must be approved by the Team Coach.
- Final team selection will take place on a date designated.
- Selected team members will be advised by email.

Team Manager and Chaperones

SLS MNC will call for expressions of interest for the Team Manager and Chaperones after final team selection is announced. To be eligible, the Team Manager and Chaperones must be current financial members of a SLSMNC Club and ensure they have met all the requirements for Working with Children checks by their Club. The MNC Board of Directors will be responsible for the Team Manager and Chaperone selection.
